CASE REASSIGNMENTS

Administrative Order: 26-01

WHEREAS, the Chief Judge is responsible for supervising the administrative business of the Eighth Judicial District Court, ensuring the quality and continuity of its services, supervising its calendar, reassigning cases as convenience or necessity requires, assuring the court's duties are timely and orderly performed, and otherwise facilitating the business of the Court; NRS 3.025; EDCR 1.30(b).

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b), that 200 open civil cases currently assigned to Department 5 aged 24 months or less shall be randomly selected and reassigned to Department 26.

IT IS HEREBY ORDERED, pursuant to EDCR 1.30(b), that 50 open civil cases currently assigned to Department 8 aged 24 months or less shall be randomly selected and reassigned to Department 26.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that 250 open civil cases currently assigned to Department 29 aged 24 months or less shall be randomly selected and reassigned to Department 26.

IT IS FURTHER ORDERED, pursuant to EDCR 1.30(b), that 2,290 open probate cases currently assigned to Department 26 shall be randomly selected and reassigned to Department 5.

1 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that 2,290 open
2 probate cases currently assigned to Department 26 shall be randomly selected and
3 reassigned to Department 8.

4 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all remaining
5 open probate cases currently assigned to Department 26 shall be reassigned to
6 Department 29.

7 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all closed
8 probate cases shall be equitably distributed among Departments 5, 8 and 29.

9 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all future
10 probate cases shall be randomly assigned and equitably distributed among Departments
11 5, 8 and 29.

12 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that Department 26
13 shall be designated an All-Civil department for future case assignments.

14 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all eviction
15 appeals currently assigned to Department 29 shall be reassigned to Department 17.

16 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all eviction
17 appeals currently assigned to Department 11 shall be reassigned to Department 14.

18 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all future
19 eviction appeals cases shall be randomly assigned and equitably distributed between
20 Departments 14 and 17.

21 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that the
22 aforementioned general civil, probate and eviction appeal case reassignments shall take
23 effect on February 9, 2026.

24 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that court
25 administration shall publish the general civil, probate and eviction appeal case
26 reassignments affected by this order on this court's website no later than February 8,
27 2026.

1 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that the following
2 Family Division case reassessments described below shall take effect on March 9, 2026.

3 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all cases
4 currently assigned to Department X shall be reassigned to Department D, and
5 Department D shall be designated as a department receiving future Civil-Domestic case
6 assignments.


7 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all cases
8 currently assigned to Department D, excepting Juvenile Protection-Sex Abuse cases,
9 shall be reassigned to Department X, and Department X shall be designated as a
10 department receiving future Dependency case assignments.

11 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all Juvenile
12 Protection-Sex Abuse cases currently assigned to Department D shall be reassigned to
13 Department L, and Department L shall be designated as a department receiving future
14 Juvenile Protection-Sex Abuse case assignments.

15 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that all Juvenile
16 Mental Health cases currently assigned to Department L shall be reassigned to
17 Department X, and Department X shall also be designated as a department receiving
18 future Juvenile Mental Health case assignments.

19 **IT IS FURTHER ORDERED**, pursuant to EDCR 1.30(b), that court
20 administration shall publish the Family Division case reassessments affected by this
21 order on this court's website no later than March 8, 2026.
