Ethics CLE Program Free for CCBA Members June 17

Ethics as the Foundation of Our Profession

Ethics in the legal profession is not merely a set of rules the lawyers must follow; it is the foundation and the framework that ensures fairness, integrity, and public confidence in the judicial process. While the Nevada Rules of Professional Conduct provide clear guidance, ethical lawyering often extends beyond what is written. It requires judgment, self-awareness, and a commitment to doing what is right even when it is not the easiest or most expedient path.

Attorneys have heavy demands in the practice of law. This includes heavy caseloads, evolving legal standards, and the pressures of client expectations. These situations can cause an attorney to question a decision regarding their ethical obligations. In order to ensure that their ethical obligations are met, an attorney needs to adhere to the duty of candor and the other ethical duties for which they are responsible. When an attorney is faced with the stresses of an ethical dilemma, the situation can create a challenging environment, and that is when adherence to

ethical principles becomes most critical. Professionalism is not situational, but a constant obligation.

In the courtroom, ethical conduct manifests in many ways. One of the most important ethical rules is the duty of candor to the tribunal. This duty states that a lawyer may not knowingly make any false statements of law or fact, or offer false evidence. This duty is very important in ensuring that our courtrooms are demonstrating public confidence by showing a dedication to justice and fairness. Judges rely on attorneys to present accurate facts and applicable law. When that trust is honored, proceedings are more efficient, and outcomes are more just. Conversely, when ethical lines are blurred, it not only undermines a particular case but also erodes confidence in the system as a whole.

As members of the bar, each attorney shares responsibility for maintaining the reputation of the profession. Mentorship, continuing legal education, and open dialogue about ethical challenges are essential in fostering a culture of accountability and excellence. The court encourages attorneys, particularly those newer to the practice, to seek guidance when faced with ethical uncertainty.

Ultimately, ethics is not an abstract concept; it is the daily practice of principled decision making. It is reflected in the choices attorneys make in their interactions with clients, colleagues, and the court. By upholding these standards, the legal community reinforces the foundation upon which our system of justice depends. **C**

Reasonable Attorney Fees Revisited

I last wrote about reasonable attorney fees nearly ten years ago. The legal market has evolved, and so, too, have some of the issues concerning fees. This article highlights two of those issues.

Reconciling NRPC 1.5 and *Brunzell*

Is there a violation of NRPC 1.5 if, while considering a fee award, a court declares a portion of the fees unreasonable? Probably not. Although NRPC 1.5(a) requires that attorney fees be reasonable, reasonableness in the attorney-client context appears to differ from reasonableness in the fee-award context because the two approaches developed independently.

NRPC 1.5(a)(1)–(8) sets forth a non-exclusive list of eight factors for determining reasonableness without regard to context. By contrast, *Brunzell v. Golden Gate National Bank*, 85 Nev. 345, 455 P.3d 51 (1969), identifies four factors in the fee-award context. Everyone knows (or should know) that despite being nearly 60 years old, *Brunzell* is alive and well. The divergence between *Brunzell* and the rule is not surprising given that *Brunzell* predates NRPC 1.5 by decades. At the time *Brunzell* was decided in 1969, Nevada’s professional rules, SCR 163 through 204, adopted October 15, 1965, did not impose a reasonableness requirement on fees. The Supreme Court of Nevada did not incorporate such a reasonableness requirement until the adoption of SCR 135 in 1986, which was based on ABA Model Rule 1.5. Pre-dating the ethical rules helps explain why *Brunzell* relied on out-of-state authority, *Schwartz v. Schwerin*, 85 Ariz. 242, 336 P.2d 144, 146 (Ariz. 1959), which itself relied on secondary sources, rather than Nevada rules or precedent, in articulating its four-factor test. *Brunzell*, 85 Nev. at 349, 455 P.3d at 51. This strongly suggests that *Brunzell*’s analysis addresses reasonableness in the context of a fee award.

Although NRPC 1.5(a) requires that attorney fees be reasonable, reasonableness in the attorney-client context appears to differ from reasonableness in the fee-award context because the two approaches developed independently.

Nevada case law supports this distinction, even if not expressly articulated. For example, *Las Vegas Review Journal v. Clark County Office of Coroner/Medical Examiner*, 138 Nev. 813, 817, 521 P.3d 1169, 1174 (2022), reviewed the district court’s analysis of a fee award exclusively under *Brunzell*, without reference to NRPC 1.5. Other cases, however, muddy the waters. In *Vassey v. Burris & Thomas LLP*, No. 86710-COA, 2024 WL 3083283, at *3 (Nev. Ct. App. June 20, 2024) (unpublished disposition), the Court of Appeals of Nevada reversed and remanded a matter involving the adjudication of an attorney lien—effectively a fee dispute between attorney and client—and instructed the district court to analyze the fees under *Brunzell*. The unpublished decision suggests that *Brunzell* trumps NRPC 1.5. *Vasey*, No. 86710-COA, 2024 WL 3083283, at *3 fn 3.

The Office of Bar Counsel of Nevada generally treats NRPC 1.5(a) as a client-protection rule. That said, a judicial finding of unreasonableness in the fee-award context may invite scrutiny under the rule. Standing alone, how-

ever, such a finding would not likely establish an ethical violation. Instead, it could prompt a fact-intensive inquiry into factors such as the terms of the engagement with the client and whether the fees were actually paid. Examination of those factors extends well beyond the scope of a court's typical *Brunzell* analysis in the fee-award context.

Do Hourly Rates Really Matter?

Although *Brunzell* does not expressly reference hourly rates, district courts routinely consider prevailing market rates as part of their reasonableness analysis. See, e.g., *Due Diligence Group, LLC v. Las Vegas Metropolitan Police Department*, Case No. A-22-853953-W, Eighth Judicial District Court, Order entered on October 19, 2022, p. 2 (observing that hourly rates inform the third and fourth *Brunzell* factors). Perhaps the best source of data on local hourly rates is the annual survey prepared by Chad Clament, Esq. and Dylan C. Ciciliano, Esq. for the Eighth Judicial District Court's Business Court Bench Bar meeting. (Chad Clament, Esq., and Dylan C. Ciciliano, Esq., "Legal Fees and Rates in Nevada," presented at the March 25, 2026, Business Court Bench/Bar Meeting). The 2026 survey reports an average attorney rate of \$628 an hour, including an average partner rate of

\$710 and an average associate rate of \$469. As the survey notes, these figures are averages and can vary significantly based on firm size, practice area, and experience level. Even so, the survey provides a useful benchmark and is likely the most detailed, comprehensive source of rate information for the local market.

Conclusion

The treatment of attorney fees continues to evolve, and the practitioner should review the latest cases and data when preparing a fee application. **C**

Five Principles for Avoiding a Legal Malpractice Lawsuit or Bar Complaint

Even excellent lawyers who do not manage their practice subject themselves to the risks of malpractice and bar complaints. Here are five principles to mitigate the risks.

1. Communication: Do it early, often, and in writing

The major impetus to bar complaints, and clients seeking legal malpractice consultations, is "failure to communicate." *Cool Hand Luke*, (1967). For example,

- Not returning phone calls or emails;
- Failing to keep the client updated;
- Not *explaining* case developments, delays, or next steps;
- Not providing copies of documents.

Clients interpret silence as neglect. Attorneys underestimate how often they need to update clients, and complications arise more from misunderstandings than from actual problems. The solution is clear—communicate.

So how do you communicate in a way that will satisfy clients and still have time to work on the case? The secret is to have systems and rules for both yourself and your staff.

Calendar communications. Do not just rely on what occurs in the case to signal that it's time to communicate. Instead, calendar regular reminders to update the client. This can easily be done with a standard calendar system, automatically with practice management programs, or with follow-ups that can be marked in email programs.

No change reports. Update the client even when there's no new development. Many clients do not realize that a case can go for months with little visible progress. Send regular updates summarizing what has happened so far, what you're waiting on, and what the next steps will be.

Send pleadings, emails, letters, transcripts, medical records, etc. One easy way to demonstrate the case is progressing is to send clients virtually every single document. When you receive or send emails, get in the habit of forwarding the messages. When pleadings are filed, deposition or hearing transcripts are received, or even medical records are obtained, consider automatically sending them to the client.

Limit follow-ups. Keeping the lines of communication open is well worth the extra effort it takes, but it can also result in additional questions. The amount of follow-up emails can be limited by, for example, stating "provided for your information only, no response required" and by letting clients know early on that they will be provided with information just so they can see what is occurring.

Billing. Another important way to show clients what is going on is by sending out billing. A key is to send out bills regularly, even if there was no work done or money due. Do not wait long periods to send bills. If it is a contingent fee case, consider sending a client a statement of the costs expended, even if the client is not required to pay the costs; this shows the client that work is being done and lets them know about the costs that will eventually come out of their share of the settlement.

Respond to all calls and emails. When a client calls or emails, make certain that it receives a response in some fashion. Make it a rule for yourself that all such communications will be responded to, for example, within 24 hours. Even if the response is that you will need to get back to the client, the client will not feel ignored.

2. Know your client, know your scope

Dennis L. Kennedy, professional ethics and malpractice attorney, emphasizes that one frequently overlooked risk is failing to clearly identify the client. While this may seem obvious, it often isn't—for example, when representing a business entity but not its officers or employees. Attorneys should advise clients in writing not only who they represent, but also who they do *not* represent. Properly drafted conflict waivers must be explained and signed, and attorneys should consider recommending that clients consult independent counsel.

Kennedy also stresses several key malpractice-avoidance practices: always issue a closing letter at the end of representation; encourage clients to obtain independent legal advice when there are conflicts; clearly define the fee and how it is calculated; never take fees before they are earned, including set or flat fees (there is no such thing as “earned on receipt”); and carefully delineate the scope of representation, including what is and is not part of the representation. Finally, never begin work without a signed fee agreement.

3. Master your calendar, and be the Master of your domain

The most obvious calendaring issue leading to malpractice claims, missed statutes of limitations, is far from the only one. Calendaring issues also occur related to timely expert designations, opposition to motions, discovery cut-off, service of the complaint within 120 days (Nev. R. Civ. Proc. 4(e)), and missed court hearings.

Every lawyer and every firm must have a calendar system that provides for clear and unmissable reminders. And there should be a second back up calendar, if not more than one. Some professional liability insurers provide discounts where dual-calendaring systems are in place. One of the calendars should not be computer-based in case of emergencies.

To make the calendaring systems effective, you must have clear policies, procedures, and rules as to who calendars, when an item is calendared, and what is calendared. Attorney Joshua P. Gilmore, partner at Bailey Kennedy, reminds that the calendaring should be done as soon as

the deadline is triggered; waiting allows forgetting. For example:

- When a new case file is opened, the attorney and designated staff should both calendar the statute of limitations. Calendar the first client status update (e.g., 30 days), a follow up status check (e.g., 60 days), and an early settlement demand or case evaluation review (e.g., 90–120 days).
- When a complaint is filed, immediately calendar the service deadline (120 days after filing, Nev. R. Civ. Proc. 4(e)); service follow-up dates (e.g., 30 days before expiration); the date to send the complaint out for service, filing jury demand (Nev. R. Civ. Proc. 38(b)(1)); the five-year trial deadline (Nev. R. Civ. Proc. 41(e)); and advance reminders well before the five-year deadline.
- As soon as a trial setting order comes in, make sure to calendar all accompanying dates, including the trial date, any pretrial conference(s), motion *in limine* deadlines, exhibit and witness disclosure deadlines, and any other court-ordered deadlines. Do not calendar only the trial date and assume the rest will be calendared later.
- When a deposition notice is received, calendar the deposition date, the deadline to object or seek a protective order, the client notification date, and the deposition preparation meeting with the client.
- When an answer is filed or received, calendar any deadlines related to mandatory arbitration exemptions, if applicable; the early case conference date; the deadline to exchange initial disclosures; the deadline to prepare and file the Joint Case Conference Report (Nev. R. Civ. Proc. 16.1); and the anticipated scheduling order issuance date.

The rules and procedures must be clear as to whose responsibility these tasks are, because when they are everyone's responsibility, they are no one's responsibility. Gilmore also cautions to be conservative when counting days, as it is better to file early than late.

4. Keeping the “trust” in your trust account

Failures in trust accounting rules are taken seriously, and strictly, by the State Bar of Nevada—even “honest mistakes” or “technical violations.” Daniel M. Hooge, chief bar counsel since 2018, finds that attorneys, especially newer attorneys, often do not recognize that the trust account is not a regular bank account. No monies that belong only to the attorney must ever go into the trust account (except an amount to cover account expenses).

Even experienced attorneys often do not realize the strict rules on withdrawing attorney fees from the trust account, and the client-by-client accounting they require.

Timing is an important consideration. Hooge stresses that attorney fees are not to be left in the trust account too long and must not be taken out too early. As soon as the fees are earned they must be withdrawn. Moreover, attorneys must refrain from withdrawing any fees until they have been fully earned, including fees designated under fixed-fee or flat-fee arrangements.

Bar counsel also frequently observes that attorneys fail to maintain a separate accounting for each client whose funds are held in trust. A separate ledger must be maintained for each client, with accurate records of all incoming and outgoing funds. This ledger must be updated as payments are received and disbursed, and not delayed until the conclusion of the case. At the end of the matter, attorneys must provide a complete accounting upon request. Nev. R. Prof. Cond. 1.15(d).

5. Stay in your lane

Notwithstanding Vinny, in the movie *My Cousin Vinny*—a newly minted attorney who took on a death penalty case and won—those attorneys who do not “stay in their lane” are bound for trouble. “Staying in your lane” does not mean not taking cases in which you are not skilled, it simply means you must get that expertise by education, co-counsel, or consultation. See Nev. R. Prof. Cond. 1.1, and Model Rules of Prof’l Conduct R. 1.1 cmt. 2 (Am. Bar Ass’n 2026).

According to Joseph P. Garin, legal malpractice defense attorney, “one of the most effective risk management tools a lawyer has is the ability to say no. Accepting work outside your practice area doesn’t expand your skill-set—it expands your exposure.” There have been many malpractice cases where highly skilled attorneys take on cases in which they are not experienced and end up being

sued for legal malpractice. Examples include a family law attorney whose lack of familiarity with military pensions costs a spouse a lifetime of benefits, a non-judgment collection attorney who does not renew the judgment within the required time window (“within 90 days before the date the judgment expires,” NRS § 17.214(1)), and a non-legal-malpractice attorney calendaring the statute of limitations from the date the attorney stopped representing the client and not from the earlier date on which the attorney stopped representing the client on the particular matter in which the malpractice occurred. See *Moon v. McDonald, Carano & Wilson LLP*, 129 Nev. 547 (2013).

Conclusion

In an era of increasing client expectations, sophisticated oversight by regulatory authorities, and the ubiquity of digital communication, risk management has become inseparable from the modern practice of law. Each of the five principles discussed—proactive communication, clear client identification and scope, meticulous calendaring, disciplined trust account management, and practicing within one’s competence—reflects a central truth: professionalism is preventive. Lawyers who integrate these systems not only protect themselves from malpractice exposure and disciplinary scrutiny but also elevate the quality and integrity of their representation. Consistent execution, not occasional compliance, is what separates safe practice from sanction. As guardians of our clients’ trust and the legal profession’s reputation, it is our duty to build habits, not hope, into the foundation of our daily practice. **G**

False: Regularly sending bills and statements, even if there is nothing due, aids in client satisfaction.

False: You must have an accounting and balance for each client for which you have money in trust.

False: NRPC 1.1 requires "Competence." This is a requirement that is not waivable. An attorney can obtain competence by study or associating in an experienced attorney, but it is not a waivable requirement.

True: Regular billing shows your client what is going on with the case and keeps them apprised of the fees and costs.

False: An attorney representing a corporation does not necessarily represent the officers or employees, and, in fact, the corporation's interests may be adverse to those of its employees and/or officers.

- 9. True or False.** Best practices require having one central calendar that is carefully maintained.

False: While it is crucial to have a central calendar that is carefully maintained, best practices include having a dual calendaring system with a separate calendar that is not kept on the computer system.

- 10. True or False.** Every attorney, secretary, and paralegal should be responsible for all calendaring.

False: Specific people should be assigned to do the calendaring. Initially, this is usually the initiating attorney and a designated staff member. While all other staff should be advised to keep an eye on calendar issues, calendaring must be assigned to specific persons, because when it's everyone's job, it is no one's job.

Lawyer's Pledge of Professionalism



Adopted in 1991 by the Clark County Bar Association

In my role as a counselor, advocate, and officer of the court, I aspire to a standard of conduct that warrants the term "professional." I seek to earn a reputation for honor, trustworthiness, and professionalism among my clients, the legal community, and the community at large. As a lawyer dedicated to the professional and ethical practice of law, I will conduct myself in accordance with the following Pledge of Professionalism: I recognize and will abide by the principle that the legal profession is devoted to public service, improvement of the administration of justice, and the uncompensated assistance to persons who cannot afford representation;

I. To a Client, a lawyer owes undivided allegiance, the full application of the lawyer's abilities, and the employment of all appropriate legal means to protect the client's legitimate rights.

- I will achieve my client's lawful objectives as expeditiously and economically as possible, and I will advise my client against pursuing any matter that is without merit;
- I will counsel my client with respect to mediation, arbitration, and other alternative methods of resolving disputes;
- I will counsel my client that a willingness to engage in settlement discussions is consistent with effective representation;
- I will advise my client that civility and courtesy are expected of all participants in the legal system, and that such qualities are not a sign of weakness; and
- I will not permit my commitment to my client's cause to interfere with my ability to provide my client with objective advice.

II. To other Counsel, their Clients, and Office Staff, a lawyer owes courtesy, candor, and cooperation in all respects not inconsistent with his or her client's interest, and scrupulous observance of all mutual agreements and understandings.

- I will be courteous and civil to other counsel, their clients and office staff, and my word is my bond;
- I will agree to reasonable requests for extensions of time and for waiver of procedural formalities when the legitimate substantive interests of my client will not be adversely affected;
- I will cooperate with other counsel when scheduling depositions and meetings;
- I will refrain from using litigation, delaying tactics, abusive discovery, or any other conduct to harass another party;
- I will serve motions and pleadings in a timely manner to allow the other party a fair opportunity to respond;
- I will concentrate on matters of substance and content, and not quarrel over matters of form; and
- I will identify for other counsel or parties all changes I make in documents submitted to me.

III. To the Court and Other Tribunals, a lawyer owes respect, diligence, candor, and punctuality.

- I will conduct myself in a professional manner and demonstrate respect for the court, other tribunals, and the law;
- I will always be candid with the court and other tribunals;
- I will be punctual in attending all matters before the court and other tribunals;
- I will communicate with other counsel in an effort to resolve disputes;
- I will refrain from filing frivolous pleadings, papers, or motions, and will voluntarily withdraw claims or defenses when it becomes apparent they do not have merit;
- I will make every effort to agree with other counsel as early as possible on the voluntary exchange of information and a plan for discovery; and
- I will advise my clients of the behavior expected of them before the court and other tribunals.

IV. To the Public, a lawyer owes the highest degree of professionalism.

- I will conduct myself in a manner that will encourage trust of the legal profession by members of the public;
- I recognize and will abide by the principle that the legal profession is devoted to public service, improvement of the administration of justice, and the uncompensated assistance to persons who cannot afford representation;
- I will treat my office staff with courtesy and respect, and will encourage them to treat others in the same manner; and
- I recognize my conduct is governed by standards of fundamental decency and courtesy, in addition to the Nevada Rules of Professional Conduct.

The Inheritance Pro Bono Built

Across Nevada, people facing life-or-death legal crises may know where to find a shelter or a food bank. Far fewer know that free legal representation exists.

In a dimly lit office of a women’s advocacy center, a young mother sat clutching a sheet of resources, too overwhelmed to process her next step. Fleeing a violent marriage with two daughters under three—she had no money, no account in her name, no paper trail proving she existed as an independent mother. Against her stood a man with resources, charm, and **an attorney.**

Before leaving the advocacy office, a social worker said: “*Legal Aid Center of Southern Nevada may be able to find you an attorney.*” This one sentence changed her life.

Intake at the Legal Aid Center of Southern Nevada got her in the door. Attorney April Greene carried justice the rest of the way. Confident, meticulous, and unshakable—Greene’s conviction drowned out every voice that had diminished her—and what came into focus was the woman she could become.

A pro bono attorney gave her the confidence to advocate for herself. Now she advocates for others and raises daughters who know that justice requires someone willing to carry it to those who cannot reach it alone.

This mother is now a law student. She carries her story forward so that no pro bono attorney ever questions whether it matters. Pro bono built the woman writing these words—and she stands as proof of its reach. **©**
